## **UCT to co-host launch of Built Environment National Logbook**

*Initiative geared towards benefitting women in the male-dominated sector*

The University of Cape Town (UCT) and the Council for the Built Environment (CBE) will co-host the official launch of the Built Environment National Logbook (BENL) on Friday, 8 March 2024.

This significant launch coincides with International Women's Day under the theme "Inspire Inclusion", highlighting the BENL's potential to benefit women in the male-dominated built environment sector.

The BENL will revolutionise the industry by addressing the slow pace of transformation, standardising the professional registration process in South Africa, and tracking candidates on their journey to professional registration. It will also provide centralised statistical data for the built environment's professionally registered persons, candidates, students, artisans, and mentors, while offering career pathing support and guidance for unemployed built environment graduates.

### **About the CBE:**

The Council for the Built Environment (CBE) is a Schedule 3A Public Entity that reports to the National Department of Public Works and Infrastructure. It is a regulatory body established under the Council for the Built Environment Act 43 of 2000 (the CBE Act) that coordinates the following six Councils for the built environment professions – architecture, landscape architecture, engineering, property valuers, project and construction management, and quantity surveying – and through memoranda of understanding these include town and regional planning, land surveying, and environmental assessment.

The CBE was established for the purpose of instilling good conduct within the built environment professions, mobilising transformation in the profession, protecting the interest of the public in the built environment and advising the South African Government on built environment related issues.
